
# **Historic South Downtown Board of Directors Meeting**

# **CALL TO ORDER** (Action)

# **Public Comment:**

Betty Lau – I want to thank HSD very much for the survey. There are many people that are ECSTATIC about it! Sound Transit has been road blocking community's voice. Looking forward to the result and animation.

# Sound Transit Poll and Animation:

- Animation shows four different routes with two different alternatives after the new tunnel is built

# Washington state allocation gives us \$950,000 for a six month grant period

- Proposing \$150k to community based organizations to spend by June 30, 2025 prep for World
   Cup
- Making funds available for our community once we get confirmation that we can spend this money.
- Contracting by end of calendar year 2024
- Might be a process of reserving supplies, LED screens
- language for the motion: The board authorizes Executive Director Kathleen Barry Johnson to begin
  working with Community-Based Organizations (CBOs) in South Downtown that are involved in
  business resiliency and planning, to increase capacity for planning for the 2026 World Cup event.
  The board authorizes the Executive Director to organize investments in our CBO partners through

June 30, 2025, not to exceed \$150,000, to support their capacity to plan for South Downtown businesses and community to benefit from the activities surrounding the 2026 World Cup. Activities can include staffing, consulting, purchasing materials, reserving resources, and other needs as determined in consultation with the CBOs.

- Motion passes unanimously

#### Second Motion:

- Approval of spending money from the same pot \$950k
- We know that public safety is a priority and a barrier for people being able to thrive
- How do we improve public safety from the waterfront to Rainier
- We want to make sure that services are available
- We need real solutions and not kick people out or move people from one neighborhood to the other
- Best way to gauge the use of our money create a services map
  - Collect data from services
  - We want to get a handle of what's going on and what's going on were.
  - Overlay hotspots
  - Want to make the map interactive
  - o Can we share this with first responders etc?
- MID, Metropolitan Improvement Dept more responsive and less aggressive than calling 911
  - A great neighborhood resource
  - Outline the list of data sources needed
- Language of the motion for the record: The board authorizes Executive Director Kathleen Barry Johnson to engage consultants to carry out the Public Safety Services Mapping project, not to exceed \$50,000 prior to June 30, 2025. The mapping project is intended to inventory current public safety activities in South Downtown, including but not limited to police/fire response programs, homeless interventions, behavioral health services, CBO-led activities, clean/safe streets, graffiti abatement, etc. The exact parameters of the services to be mapped will be decided in consultation with community members and service providers.
