

POLICY AND ADVOCACY UPDATES (Information)

- 2024 Legislative Session Prep
- Pier 48 Status, Coalition
- Most Endangered Designation Video

Session Prep:

o Ashley-Nichole: 2024 Legislative Session starts January 8, 2024. To prepare for legislative session, we have meetings scheduled with legislators in our district and surrounding areas, educating legislators about the work HSD does. This includes HB 1510, especially for why it's important for outside legislators to vote for this. Ashley will be meeting with other legislators to hear what other big bills are. Ramping up to get our bill over to the Governor's desk.

• Pier 48 Status:

The first coalition meeting was held November 17, 2023, with 10 people in attendance. They met to discuss the purpose and vision for the group. Staff debriefed the group with the governor's office and WA State Ferries: HSD staff were able to meet with the governor's office and Joy Shigaki (Friends of the Waterfront) to bring in community's concerns about Pier 48 and the future and vision; able to hear from WA State Ferries about their interest, they see opportunities for foot ferries for finger docks and different regions to connect to Seattle; also opportunity for electrification of ferry fleet (longer timeline, cheaper than electrifying bigger boats, hybridizing larger boats). Ferry system biggest polluter of Puget Sound, electrifying will help.

 This coalition will be meeting every 6 weeks and Ashley will be giving updates from joint transportation committee and give updates on what legislature is thinking all things transportation

• C40 Cities:

- o The overwater portion overwater potion of Pier 48 needs to be removed for environmental remediation. Electrification coming over across the sound to Pier 48 and this can't be done until overwater portion is gone. Currently looking for additional funding. City of Seattle had an idea that Pier 48 could be submitted to C40 Cities, Reinventing Cities competition. It's a design competition and Pier 48 already has a lot of design but we could still submit. The hope is to work with the Pier 48 coalition to figure out strategically what the best approach is. The winner of the competition gains site control.
 - From Aleksa: wouldn't this put us in competition for funding with other neighborhood groups that we would normally support? Kathleen: normally, we wouldn't apply if other neighborhood groups were applying. Staff will check with the Coalition to confirm and/or see if we could do it in collaboration or see if one of the other orgs would want to go for it.

Most Endangered Place Video:

o Madrona Bureau has been working on this video, which is an opportunity for the community to share their stories, partners to share their stories. The plan is to roll out the video in mid-December on 12/11. Currently building a landing page on the website for the video which will include resources for the community. There will be a section for folks to leave their story and connect with HSD, space for multilingual resources for access, testimony and a timeline of past government and policy harms. Staff is working to prepare community and partners so no one is surprised when we roll out the video. Collecting short testimony about designation and bright lights in the CID, what is worth celebrating and exciting and wonderful of a place. SOUND TRANSIT UPDATE (Information)

- Nov 15 Workshop/Open House: public comment on posters/ST ideas from the past two years and where they think they're going next
- Timeline updates
 - Looking at planned workshops for preferred alternatives ST is studying. Update on naming: North
 of CID station now called Pioneer Square Midtown Station. South of CID Station is being called
 Dearborn St Station.
 - o There will be five workshops in 2024-2025, allow for deeper dives in to the projects, where people can ask more pointed questions.
 - o Currently 2025 is when we should expect to see new draft EIS. This is a long process.
 - o Early 2025 would be final EIS. Summer 2026 Final project chosen. Opened by 2039.
- Thriving Communities Grant, HSD submitted grant letter of interest. This is a Federal Program we're able to apply for as an entity that the state created. We're not usually grant applicants, but in this case we're not competing with local organizations because there are only a few organizations who are eligible to apply. HSD staff spoke with those few and they're fine being partners. We will know some time in 2024 about the grant status. This will allow HSD to hire people and do work with community partners on all of our transportation planning related efforts, should address wholistically how people live. It would be exciting if we get the funding.

UNREINFORCED MASONRY (Information)

Presenter: MaryKate Ryan

- Unreinforced Masonry, passed an alternate pathway that is supported by a director's rule: if you retrofit your building voluntarily to this director's rule, they will not make you go back and do this work.
- Map: unreinforced masonry buildings within CID and PS: https://www.google.com/maps/d/edit?mid=10vXI7HzjQPvtJ8cSm0mJo5TWwZdctGs&usp=sharing
- Everything in green is a substantial alternation doesn't need more work; blue is a permitted retrofit, probably okay now as well; yellow/pink, no visible retrofit or a visible retrofit on the outside of the building, many of those don't meet modern standards for retrofitting
- HSD can help: ways to help do some soils and vibrations testing block by block, invest in giving information to property owners in our neighborhoods to move forward with retrofitting engineering to work on outfitting their buildings.
- What are the funding options that would allow them to retrofit their buildings without evicting current tenants? Would like to have those financing options in place before moving forward with retrofitting
- Needing to cultivate a city council member champion
